LA MANCHA FUND STRENGTHENS ITS SUPPORT FOR GREENHEART GOLD BY INCREASING ITS STAKE TO 5%

London, 25 September 2025 – La Mancha Resource Capital LLP ("La Mancha"), the portfolio manager to La Mancha Resource Fund SCSp (the "Fund"), today announces that the Fund has increased its holding in Greenheart Gold Inc. ("Greenheart" or the "Company") by purchasing 2 million shares in the open market, bringing the Fund's holding to approximately 5%.

La Mancha is a founding shareholder of Greenheart after the Company's spin-out that followed the closing of the G Mining-Reunion Gold merger in July 2024. Since commencing activities, Greenheart has achieved a series of important milestones that underscore the strength of its management team and its strategy to rapidly advance a highly prospective exploration portfolio in the Guiana Shield.

The Company has delivered strong drilling results from the initial RC drilling program at its Majorodam property in Suriname and has now launched a follow-up diamond drilling program in Majorodam as well as a Phase 1 diamond drill program at its Tamakay project in Guyana. Since inception, Greenheart Gold has also moved quickly to expand its exploration land position by more than doubling its land position at Majorodam and securing options to acquire a 100% interest in both the Igab and Tosso Creek projects in Suriname.

Vincent Benoit, CEO and Managing Partner of La Mancha, commented: "The Fund's investment in Greenheart represents a further step toward the delivery of La Mancha's strategy of growth in Latin America, and we are very excited about the regional exploration potential of the Guiana Shield. We have great confidence in the proven management team at Greenheart to replicate the achievements of their past discoveries, and we are delighted to have this opportunity to strengthen our support for the Company."
