## **LA MANCHA SUPPORTS FALCON ENERGY MATERIALS' FINANCING TO ADVANCE FULL-SCALE PLANT DEVELOPMENT**

**London, 10 February 2026** – La Mancha Resource Capital LLP (“La Mancha”), portfolio manager to La Mancha Resource Fund SCSp (the “Fund”), welcomes Falcon Energy Materials plc’s (“Falcon” or the “Company”) announcement of its C\$25 million private placement financing to support the next phase of development of its integrated energy materials platform.

La Mancha confirms that the Fund will be participating in the private placement to maintain its ownership at approximately 23.5% of Falcon’s issued and outstanding share capital on an undiluted basis following completion of the financing.

La Mancha’s participation underscores its continued conviction in Falcon’s development strategy and supports the Company as it advances detailed engineering, permitting and execution activities toward construction readiness, with the objective of financing and launching the full-scale plant in 2026.

**Vincent Benoit, CEO and Managing Partner of La Mancha, commented:** *“This financing represents an important milestone for Falcon as it progresses toward becoming a leading producer of Active Anode Material, supplying battery gigafactories for electric vehicles. With solid advances across technical and project development workstreams, this capital raise strengthens Falcon’s path toward construction of its full-scale CSPG plant, targeted for 2026, to be developed in partnership with Hensen, a leading graphite processing technology provider. The participation of new, high-quality investors alongside our existing shareholders underscores strong confidence in Falcon’s strategy and execution.”*
