

# La Mancha welcomes pivotal partnership between SRG Mining and C-One

London, 31 July 2023 – La Mancha Resource Capital LLP ("La Mancha"), investment advisor to La Mancha Resource Fund SCSp (the "Fund"), which is the largest shareholder of SRG Mining Inc. ("SRG"), welcomes SRG's announced strategic cooperation and investment agreement ("Agreement") with Carbon ONE New Energy Group Co., Ltd ("C-One"), a leading industry figure in graphite and anode production. Under the terms of the Agreement, C-One will acquire a 19.4% stake in SRG, mirroring the Fund's pro-forma ownership, and collaborate with SRG with the objective of developing SRG into a fully integrated graphite producer, supplying active anode materials to the Western world.

La Mancha believes C-One's investment advances SRG's objective of becoming a Western leader in natural graphite anode production, and La Mancha hopes it will fast-track SRG's development timeline and result in substantial cost savings associated with building a graphite anode plant sufficient to meet battery manufacturer standards. By sharing its industry-leading know-how in constructing and operating anode plants, La Mancha believes C-One is the ideal partner to boost SRG's expertise and places it ahead of its Western competitors.

Under the terms of the proposed transaction, the Fund will partially exercise its pre-existing antidilution rights such that, once both C-One's and the Fund's investments have closed, the Fund and C-One will own 19.4% of SRG's issued and outstanding common shares.

Vincent Benoit, Partner & Co-chief Investment Officer of La Mancha, said:

"We congratulate SRG's management team on their agreement with C-One and are delighted to welcome our prospective new fellow shareholder, C-One, onboard. C-One's significant investment in SRG aligns their interests with all shareholders, distinguishing its strategic alliance with SRG from joint ventures or licensing royalties. Further, we hope that C-One's recent construction of an anode plant in China will yield valuable synergies during SRG's feasibility study and construction phases."

Completion of the transaction is expected to occur by or in Q1 2024 once various conditions have been satisfied and relevant regulatory approvals have been obtained. The common shares will be subject to a four month and one day hold period from the date of their issuance in accordance with applicable securities laws and the policies of the TSX Venture Exchange.
